## **NDT Opportunity** (Karen Morgenstein)

Karen spoke about the possibility of utilizing NEIT's NDT learning books/tapes by Jan Davis as an educational opportunity for those interested and fundraising event for RIOTA.

NEIT has 3 books/tapes to utilize as a series, or RIOTA could just offer 1 book as an educational opportunity since the information would take approximately 6-8hrs to review. Details still need to be finalized regarding breaking the info up into 2 different nights or having the event on a Saturday.

Each book offers 15 contact hrs at \$75 / person. Cost still needs to be finalized.

Karen and Trish agreed to research this further with the potential of the NDT tapes being a special event for RIOTA members in the fall.

#### **Advertising Policy** (Gina Alston)

**Current Policy** 

\$75 for ½ page; \$100 for ½ page; \$150 for full page – ad gets sent via mass e-mail & newsletter; there is a lag-time for membership benefit of 1 week before ad gets posted on the RIOTA website. Recently, there have been a few complaints from RIOTA members regarding the content of ads placed in that the ads are not OT specific.

The RIOTA Board decided to limit ad content that is sent to members via email to OT specific jobs or educational opportunities. Website and newsletter ads can include any other advertising as this is used for fundraising efforts for RIOTA.

#### Website & Newsletter Updates (Michelle)

Michelle indicated that she has received a few complaints about the lag time of the ad going on the RIOTA website.

The RIOTA board decided to continue the delay as a member benefit and to increase the price of ad if advertiser wants ad to go directly to the website.

Michelle also indicated that there is an issue with the system currently used by RIOTA to receive funds for ads. Currently Michelle or Becky wait to receive the ad check, then post the ad. Advertisers have indicated that they want the ad posted immediately. Michelle indicated she will research "Pay Pal" or an alternative online pay system to alleviate this issue.

Michelle indicated that the DOH list needs to be updated. Gina agreed to update the list in time for the September membership drive. (List received few days after this meeting- Gina sent DOH attachment to both Jeanette Gilbert, administrative asst and Michelle Lamoureux, website editor.)

Michelle asked if RIOTA's "Incorporation Papers" are up-to-date. Gina indicated she will contact Becky about this. (After contacting Becky, Gina found out that incorporation papers are up to date and all set. Papers kept in archives- see Sue Higgins, historian, for more information.)

The CMS approved codes for DMA for orthotics & prosthetics are available with an attached fee schedule.

Time is running out to obtain an NPI number! May 23<sup>rd</sup> 2007 is the compliance date to obtain an NPI number for large health plans and providers. Small health plans and providers have until 5/23/08. The NPI number will improve the Medicare and Medicaid programs, and other Federal health programs and private health programs, and the effectiveness and efficiency of the health care industry in general by simplifying the administration of the health care system and enabling the efficient electronic transmission of certain health information.
