AOTA's annual conference was held in Orlando, Florida this year. I was fortunate enough to spend a few days pre-conference at the face to face RA meeting. I brought with me your thoughts and concerns which were expressed at the RIOTA April meeting, regarding the proposed motions, including the AOTA restructuring motion. I greatly appreciate all of your feedback and comments; your input makes my discussions, debates and voting much more focused and directed as I represent the members of Rhode Island.

This year the Assembly considered several motions and several substitutes, as well as a few motions that were introduced during the meeting itself. For these 'new' motions, I did not have the benefit of constituent feedback and therefore it was helpful to have had our discussions and emails to work from prior to debate and vote. Below are the original motions and the offered substitute motions with their outcomes.

Participation review/ad hoc Committee Substitute Motion

The substitute motion regarding the Presidents Ad hoc committee findings related to participation and reorganization reads: (sic) I move the President to appoint an ad hoc committee composed of the following people: Commission Chairs (4), SISC Chair, RA Speaker, and RA member, a member of the current participation ad hoc, 3 members at-large, a member of ASAP, an ASD steering Committee member, and OTA member, an officer of the Association and a Chairperson to continue to explore opportunities for both procedural and organizational changes designed to respond to the concerns raised by the President in the recently defeated Participation Review motion with a report and recommended action to the Assembly in the Fall 2010.

We, the Assembly, felt this newly proposed committee would better serve to meet the intent of the President as well as to address the many concerns emphasized by our constituents.

Finally, I would like to take a moment to thank Amy Battles-Borkowski for accepting the nomination for RI RA rep. She will be appointed by the Speaker of the Assembly on June 1, 2010. I am grateful for her enthusiasm, her generous offer of time and her professional attitude toward volunteerism.
